NOTICE IS HEREBY GIVEN that the City Council of the City of Riverbank will conduct a Special (hybrid) Council meeting, and hold the first of four (4) public hearings on Wednesday, November 3, 2021 at 6:00 p.m. or soon thereafter as practical via the Zoom virtual platform and in-person attendance in the City Council Chambers at 6707 Third Street, Suite B, Riverbank, CA, This meeting will be held in accordance with the Brown Act amendment (AB 361) in regards to teleconference/virtual public meeting requirements, the Gover-nor's "reopening" orders, and the recent California Department of Public Health

## COVID orders (all of which are subject to change before the meeting date). This public hearing is to consider the following matter: INTRODUCTION TO THE CITY OF RIVERBANK REDISTRICTING PROCESS OF THE CITY COUNCILMEMBER ELECTION DISTRICT BOUNDARIES DESCRIPTION: Every 10 years after the U.S. Census, the City of Riverbank

must perform a "redistricting" process to balance the population in each of the City's four (4) City Councilmember district boundaries. The City Council will 1) receive a report from staff and the Consultant on the redistricting process and permissible criteria to be considered to redraw City Council election district boundaries; and 2) conduct a public hearing to receive public input on communities of interest and potential district boundaries

FUTURE PUBLIC HEARINGS: The remaining three (3) public hearings to be conducted will on: Tuesday, January 4, 2022; March 8, 2022, and April 12, 2022. Visit the City's website at https://redistrictingriverbank.org/.


